



New Birth of Freedom Council Family Scouting Pack Survey and Early Adopter Enrollment Form

The New Birth of Freedom Council, BSA has decided to participate as an Early Adopter Council for the Family Scouting program, therefore, Packs and chartered organizations may choose to welcome girls into the Scouting program before the fall launch. Interested Packs must submit their Enrollment Application and be approved by **March 15th** or will have to wait until the full launch in the fall.

Criteria for a Pack to enroll as an Early Adopter:

- 1 Pack must have successfully completed their recharter at the end of 2017.
- 2 Pack Committee and chartered partner must agree to participate as a family pack, which is defined as a pack with both boy-dens and girl-dens.
- 3 Pack must agree to use online registration. There will be no paper applications accepted.
- 4 Pack must have all of its leaders trained for their position.
- 5 Pack must agree to help each new Scout complete their RANK requirement by May 31, 2018 or by the end of the school year. Each Pack will need to develop a plan to make sure that this is accomplished in the modified window of time.
- 6 Pack must register a minimum of 4 girls into an existing pack in an all-girl den.*
- 7 Pack must use the current Cub Scout program and resources.
- 8 Pack must uphold membership policies and follow the guidelines in the Unit Performance Guide.
- 9 Pack must provide data and statistics on their activities to the National Council.
- 10 Packs are encouraged to participate in Family Camping, Day Camp, and Resident Camp

**Ideally, a pack will create an all-girl den for each age group. It is understood that in some cases this will not be possible and the all-girl den may have girls from different age groups. The requirement to complete ranks applies in either scenario. Please, indicate who will be serving as den leaders for the dens your pack intends to have. (Only complete if participating in the early adopter program)*
