Background

The Scouting America "Guide to Advancement 2025", Chapter 9.0.2.10, provides for individual councils to establish provisions as to when the Eagle Scout Service Project Fundraising application will be required to be submitted to the councilfor approval. Below are the proposed requirements for the Eagle Scout Service Project Fundraising application for the New Birth of Freedom Council.

Procedures and Limitations on Eagle Scout Service Project Fundraising Application

The Eagle Scout Service Project Fundraising Application must be used in obtaining approval for service project fundraising or securing donations of materials*. Send the completed form to your local council service center, where it will be routed to the District Executive for approval. This is in accordance with the Guide to Advancement(9.0.2.10)

All Eagle Scout Service Project Fundraising Applications must be submitted <u>at least two weeks before your fundraising efforts.</u> Fundraising Applications will be accepted any time after project approval has been given by the district advancement committee and the final submission of the Eagle Scout Workbook.

* This application is not necessary for contributions from the candidate, his parents or relatives, his unit or its chartered organization, parents or members of his unit, or the beneficiary. All money left over, regardless of the source, goes to the beneficiary.

If the standards below are met, your fundraising effort likely will be approved.

- 1. Eagle Scout service projects may not be fundraisers. In other words, the candidate may not stage an effort that primarily collects money, even if it is for a worthy charity. Fundraising is permitted only for securing materials and otherwise facilitating a project. Unless the effort involves contributions only from the beneficiary, the candidate, his parents or relatives, his unit or its chartered organization, or from parents or members in his unit, it must be approved by the local council. This is achieved by submitting the Eagle Scout Service Project Fundraising Application.
- 2. It must be clear to all donors or event participants that the money is being raised on behalf of the project beneficiary. Once collected, money raised must be turned over for deposit to an account of the beneficiary or the candidate's unit until needed for the project. If the unit receives the funds, it must release them to the beneficiary once expenses have been paid.
- 3. Any contracts must be signed by a responsible adult, acting as an individual, without reference to the Boy Scouts of America. The person who signs the contract is personally liable. Contracts must not and cannot bind the local council, Scouting America, or the unit's chartered organization.
- 4. If something is to be sold, we want people to buy it because it is a quality product, not just because of an association with Scouting. Buyers or donors must be informed that the money will be used for an Eagle Scout service project to benefit the school, religious institution, or community chosen, and any funds left over will go to that beneficiary.

- 5. Any products sold or fundraising activities conducted must be in keeping with the ideals and principles of the BSA. For example, they must not include raffles or other games of chance.
- 6. Should any donors want documentation of a gift, this must be provided through the project beneficiary, not Scouting America. If a donor or fundraising participant wants a receipt, this, too, must be provided in the name of the beneficiary.
- 7. The New Birth of Freedom Council does not permit Scouts to solicit funds on behalf of other organizations, including for Eagle Scout Service projects. When solicitation of funds for a project is needed, the request must come from the project beneficiary using their letterhead or other forms of the beneficiary's identification to accompany the request.

An Eagle Scout Service Project Fundraising Application must be submitted under the following criteria.

• The Eagle Candidate through the beneficiary is seeking \$1,000.00 or more of donations, materials, money, and/or discounts.

An Eagle Scout Service Project Fundraising Application does not need to be submitted under the following criteria:

- Any donation, regardless of quantity, from the beneficiary, the candidate, parents/relatives, their unit or charter organization, or from parents or members of the unit.
- If a candidate is given a discount or donation of materials without solicitation at the time of purchase, it is OK to accept it, and the application is not required.

Please note that Eagle Scout Service Projects cannot be fundraisers themselves. It should be clear that funding is being used to help the beneficiary, and any leftover funding will be turned over to them.

Fundraising applications must be submitted to the New Birth of Freedom Council at least two weeks prior to any fundraising activity.
